ORDINANCE NO. 181 OF 2018

**AN ORDINANCE AMENDING TOWNSHIP ORDINANCE 99-1999 TO
AMEND THE VACANCY REQUIREMENTS OF THE
TOWNSHIP OPEN SPACE REVIEW BOARD**

WHEREAS, the Board of Supervisors has met the procedural requirements of the Second Class Township Code, 53 P.S. § 65101, *et seq.*, for the adoption of the proposed ordinance;

WHEREAS, the Second Class Township Code authorizes the Board of Supervisors to make and adopt Ordinances that are consistent with the Constitution and the laws of the Commonwealth that it deems necessary for the proper management and control of the Township and welfare of the Township and its citizens;

WHEREAS, the Board of Supervisors has determined that an amendment to Township Ordinance 99-1999, which established the Open Space Review Board, as subsequently amended by Township Ordinance 177-2017, is desired to amend the vacancy requirements and provisions of the Open Space Review Board members;

WHEREAS, the Board of Supervisors, after due consideration of the proposed ordinance at a duly advertised public hearing, has determined that the health, safety, and general welfare of the residents of the Township will be served by amendments of West Vincent Township Ordinance 99-1999, as amended by Township Ordinance 177-2017;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Board of Supervisors for West Vincent Township, and it is hereby ordained and enacted, by the authority of the same, to wit:


SECTION 1. ORDINANCE AMENDMENT. West Vincent Township Ordinance No. 99-1999, establishing the West Vincent Township Open Space Review Board, Section 1.3, (Vacancies), as amended by Township Ordinance 177-2017, is hereby amended as follows:

Section 1.3. Vacancies. When a member of the Open Space Review Board appointed as a member of the Planning Commission or Environmental Advisory Council shall, for any reason, no longer be a member of such commission or council, such member shall also no longer continue as a member of the Open Space Review Board, effective the end date of the membership on such commission or council. When any vacancies shall occur in the membership of the Open Space Review Board, the Board of Supervisors shall fill such vacancies in the membership for the remaining unexpired term.


- SECTION 2. REPEALER.** All Ordinances or parts of Ordinances inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed.
- SECTION 3. REVISIONS.** The Township Board of Supervisors does hereby reserve the right, from time to time, to adopt modifications of, supplements to, or amendments of its Ordinance, including this provision.
- SECTION 4. SEVERABILITY.** In the event that any section, sentence, clause, phrase or word of this Ordinance shall be declared illegal, invalid or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent, preclude or otherwise foreclose enforcement of any of the remaining portions of this Ordinance.
- SECTION 5. EFFECTIVE DATE.** This amendment shall become effective five (5) days after date of adoption.
- SECTION 6. FAILURE TO ENFORCE NOT A WAIVER.** The failure of Township to enforce any provision of this Ordinance shall not constitute a waiver by the Township of its rights of future enforcement hereunder.




