West Vincent Township Park Rules & Regulations

1. Park users must abide by all signs.
2. Park hours: Dawn to Dusk.
3. No littering or dumping.
4. Pets must be leashed at all times. Animal waste must be removed by the owner.
5. No fires or camping.
6. No commercial activity or soliciting.
7. Motor vehicles are permitted in the driveways and park lot areas only.
8. No alcohol or illegal substances allowed in the park at any time.
9. No illegal discharging of firearms, and no fireworks, rockets, explosives or weapons.
10. No excessive noise or indecent language.
11. No hunting or shooting.
12. No demonstrations without specific permission from the Township Manager.
13. No glass containers.
14. No skateboarding or roller skating/blading.
15. Balloon Bounce structures/devices are not permitted.
16. Staking canopies or tents to the ground is not permitted without the prior approval of the Township Manager.
17. No defacing or damaging property.
18. No wading, swimming or ice skating in the pond.
19. No camping, archery, golfing or horseback riding.
20. No disturbing wildlife or vegetation.
21. Fees must be paid prior to reservation date.
22. All park visitors and users must agree to indemnify, defend and hold harmless West Vincent Township, its agents, employees, servants, successors and assigns from any and all claims and losses in connection with the usage of the park and its facilities.
23. Township Manager approval is required for:
 - a. Pavilion reservation
 - b. League use of sports fields
 - c. Parades
 - d. Ceremonies
 - e. Musical events
 - f. Theatrical or other entertainment
 - g. Public meetings or gatherings
