DESCRIBE THE PRESENT AND ORIGINAL (If known) PHYSICAL APPEARANCE

The Robert Rooke house consists of two distinct sections. The original section is a 2½ story fieldstone structure, two bays across, one bay deep, with gabled roof and a brick chimney at the east gable end. A three story fieldstone addition was built soon after 1841 perpendicular to the original house, attached to its western wall. The original portion of the enlarged house became the kitchen wing.

The 1841 addition is the most interesting because it combines Georgian and early Victorian features in its construction. The west (front) elevation is five bays across with centrally located door, denoting a central hallway floor plan. The north gable end is two bays deep, the south gable end, one bay, and both ends have six over six sash windows with panelled shutters on the first floor and louvered shutters on the second and third levels. The third story windows are eyebrow windows on the west (front) elevation with three over three sash with louvered shutters. Windows on the first and second levels are six over six sash with panelled shutters on the first floor and louvered shutters on the second floor. This section has a gable roof with a low pitch and brick end chimneys. A deep bracketed cornice extends along both the east and west rooflines, and the north and south gable ends have a heavy boxed cornice with return. The entire structure is stuccoed and whitewashed.

The front door is topped by a rectangular transom and

flanked by narrow vertical sidelights. The door, transom, and sidelights are set within deep panelled door reveals, and the entire complex is framed by a heavy molding topped with an eared architrave.

The house has undergone few exterior alterations except for the addition of a modern shingle roof over both sections. Original six over six sash windows in the older section have been replaced by later two over two sash windows.

STATEMENT OF SIGNIFICANCE

The house is known primarily as the residence of Robert Rooke, a prosperous meat packer, who purchased the property in 1841. Soon after, he built a 3 story stone addition to the original 2½ story, gable roofed structure. This enlarged building is significant as an example of the localized practice of constructing a large mid-19th century addition perpendicular to an existing, smaller structure.

The addition is further significant because it combines early Victorian and more common Georgian architectural features. Traditional characteristics include a center hall plan, five bays across and two bays deep, end chimneys, and six over six sash windows with panelled and louvered shutters. Early Victorian features that are incorporated in the structure include the low pitched gable roof, deep bracketed cornice, and eyebrow windows.
