RESOLUTION NO. 7-2016

**A RESOLUTION OF WEST VINCENT TOWNSHIP AMENDING THE
APPOINTMENT TERMS OF THE WEST VINCENT SUSTAINABILITY COMMITTEE
TO ESTABLISH THREE YEAR TERMS WITH NO MORE THAN
THREE MEMBERS' TERMS EXPIRING ON THE SAME YEAR**

WHEREAS, Pursuant to Section IX.B of the West Vincent Township Sustainability Plan, adopted December 12, 2011, the West Vincent Township Board of Supervisors established the Township Sustainability Committee (hereinafter, "Committee") pursuant to Resolution No. 6-2012, enacted January 3, 2012;

WHEREAS, Resolution 6-2012, Section Two, "Appointment, Term, and Vacancy" established, in part, that the nine (9) members appointed to the Committee would serve for a term of four (4) years with no more than two (2) members' terms expiring on the same year;

WHEREAS, the Board of Supervisors desires to amend Resolution 6-2012 to establish three (3) year terms for the Committee with three (3) members' terms expiring on the same year.

NOW THEREFORE BE IT RESOLVED, and it hereby resolved by the Board of Supervisors of West Vincent Township this 16th day of February, 2016 that Resolution 6-2012 is hereby amended as follows:

Section 1. Resolution Amendment. West Vincent Township Resolution 6-2012, Section 2, entitled "Appointment, Term, and Vacancy", is hereby deleted in its entirety and amended as follows:

Section 2. Appointment, Term, and Vacancy

The Committee shall consist of nine (9) members appointed by the Board of Supervisors for a term of three (3) years or until their successors are appointed. Hereinafter, members appointed to the Committee shall be appointed to terms of length such that not more than three (3) members' terms expire on the same year. The members of the Committee shall serve without compensation. The Chairman of the Committee shall promptly notify the Board of Supervisors of any vacancies on the Committee and such vacancy shall be filled for the unexpired term by said Board of Supervisors. Hereafter, the following persons shall initially be appointed to the Committee with terms expiring upon December 31st of the associated years listed:

1. Kip Archinal, 2016
2. James McQuillan, 2016
3. Vacancy, 2016
4. Penny Fulton, 2017

5. Nicole Keegan, 2017
6. Bryan Sladky, 2017
7. Sam Cantrell, 2018
8. Bernie Couris, 2018
9. Ben James, 2018

Section 2. Repealer. All resolutions or parts of resolutions inconsistent herewith or in conflict with any of the specific terms enacted hereby, to the extent of said inconsistencies or conflicts, are hereby specifically repealed.

Section 3. Severability. In the event that any section, sentence, clause, phrase or word of this Resolution shall be declared illegal, invalid or unconstitutional by any Court of competent jurisdiction, such declaration shall not prevent, preclude or otherwise foreclose enforcement of any of the remaining portions of this Resolution.

Section 4. Effective Date. This Resolution shall become effective upon adoption.

Section 5. Failure to Enforce Not a Waiver. The failure of West Vincent Township to enforce any provision of this Resolution shall not constitute a waiver by the Township of its rights of future enforcement hereunder.
